1. Information We Collect

We may collect personal information such as names, email addresses, phone numbers, and SMS consent when voluntarily submitted by our visitors. In addition, we may collect non-personally identifiable information such as browser type, operating system, IP address, and device information to help improve our website and enhance your user experience.

2. Use of Information

We use the personal information collected solely for the purposes of:

- Providing requested services and responding to inquiries
- Processing SMS communications and ensuring effective communication
- Improving our website's content, functionality, and overall user experience

Please note: *SMS opt-in and phone numbers collected for SMS communication purposes will not be shared with any third party and affiliates for marketing purposes*

3. Disclosure of Personal Information

We do not sell, trade, or otherwise transfer your personal information to outside parties except in the following circumstances:

- **Service Providers:** We may share your information with trusted third-party service providers who assist us in operating our website and conducting our business. These providers are contractually obligated to keep your information confidential and use it only for the specified purposes.
- **Legal Compliance:** We may release your information when required by law or in response to valid requests from public authorities.
- **Business Transfers:** In the event of a merger, acquisition, or asset sale, personal information may be transferred as part of the transaction.

Again, SMS consent is never shared with third parties for marketing purposes.

4. Cookies

Our website may utilize cookies—small data files stored on your browser—to personalize your experience, track preferences, analyze website traffic, and improve functionality. You can choose to accept or decline cookies through your web browser settings; however, this may limit some features of the website.

5. Security Measures

We implement industry-standard security measures to protect against unauthorized access, alteration, disclosure, or destruction of personal information stored on our website. While we strive to protect your information, please be aware that no method of data transmission or storage is 100% secure.

6. Links to External Websites

Our website may contain links to external websites that are not under our control. We are not responsible for the privacy practices or the content of these sites. We encourage you to review the privacy statements of any external websites you visit.

7. Children's Privacy

Protecting the privacy of children is very important to us. Our website is not intended for use by individuals under the age of 13.
